Thank you for your interest in Capital Live Scan's fingerprint card conversion service. We offer a convenient and affordable alternative that can save you both time and travel costs if you are located outside of California but need to have a California Department of Justice (CA DOJ) and/or Federal Bureau of Investigation (FBI) background check completed for employment, licensing or certification.

Our service uses high-quality scanning technology to convert standard ink fingerprint cards (FD-258) into electronic Live Scan transactions. This means your fingerprints can be submitted electronically—just as if you had come in for a Live Scan—allowing your application to be processed just as quickly.

You'll find the attached instructions for sending your ink fingerprint cards to Capital Live Scan. We'll handle the conversion and submit your fingerprints to the CA DOJ and, if needed, the FBI.

Completion of Forms:

- Ink Fingerprint Cards (FD-258) can be obtained at most fingerprint provider locations or from a Police or Sheriff Department's, where you can also be fingerprinted.
- Please include two (2) unique and distinct fingerprint cards (FD-258) for submission, in case one card is not readable. Please note: Applicant fingerprints must be rolled onto each card.
 Copies of the same card will not be accepted. Do not submit copies of the same card or your package will not be processed.
- A copy of a valid government-issued photo identification (front and back) <u>MUST</u> be included. <u>Packets will not be processed without this</u>.
- If fingerprints are submitted on a copy of the FD-258 card instead of the official card stock FD-258, applicants must ensure that the paper is **not** folded, as this will degrade the quality of the fingerprint images and may result in the fingerprints being rejected by the CA DOJ and/or FBI.
- The Applicant Information section of the ink card <u>must</u> be completed: Date of Birth, Name, Social Security Number and signature.
- The Request for Live Scan Service Form (BCIA 8016) complete with the agency information at the top: ORI, Agency Name/Address, Mail Code and Contact Person, as well as the level of service (DOJ or DOJ and FBI), and the Applicant Information section <u>must</u> be completed.
- The Declaration of Official Taking Fingerprints form **must** be included.
- You will need to obtain a Request for Live Scan Service form (BCIA 8016) from the California
 agency you are applying with. You must obtain this form. It should be complete with the agency
 information at the top: ORI, Agency Name/Address, Mail Code and Contact Person, as well as the
 level of service (DOJ, or DOJ and FBI). You must complete the applicant information section.


Once we receive your two (2) distinct fingerprint cards and other required documentation, we will scan and electronically submit your fingerprints to the California DOJ, and if applicable, FBI.

We will return two (2) copies of your Request for Live Scan form to you if a prepaid FedEx label is provided. One is for your records and the other copy should be sent to the requesting agency (the agency you are applying with). The CA DOJ and the FBI will complete your criminal background check and forward the results directly to the requesting agency.

Capital Live Scan will retain the two physical fingerprint cards for 90 days; in case the fingerprints are rejected and need to be resubmitted. After that, one of the fingerprint cards, along with the Request for Live Scan Service form will be retained digitally for 12 months, per California DOJ requirements. After the retention period has lapsed, all fingerprint cards and documentation will be confidentially shredded.


WHAT YOU WILL NEED

1. FD-258 FINGERPRINT CARDS, two (2) distinct fingerprint cards for submission ensuring that each card contains unique prints (not a copy), complete with applicant information and fingerprint images. Make sure the technician rolling your fingerprints COMPLETED AND RETURNS TO YOU THE DECLARATION OF OFFICIAL TAKING FINGERPRINTS: PAGE 4.



2. 3 COPIES OF THE REQUEST FOR LIVE SCAN FORM from the requesting agency with ALL requesting agency information and applicant information sections completed.





- 3. Copy of your VALID, GOVERNMENT ISSUED, PHOTO IDENTIFICATION (Front and Back).
- 4. Completed CONTACT INFORMATION PAGE 5
- 5. CHECK, CASHIER'S CHECK or CREDIT CARD AUTHORIZATIN COMPLETED FOR \$100.00 made out to Capital Live Scan or return a completed Credit Card Authorization form. The \$100 fee includes the Capital Live Scan processing fee of \$51.00 and the Government fees (CA DOJ \$32 and FBI \$17).
- 6. INCLUDE A PREPAID, SELF ADDRESSED, **FedEx** RETURN Label so we can return copies of your Request for Live Scan Service form to you once your fingerprints are converted and transmitted.
